BACKGROUND:

means Castings Technology International Ltd, Advanced Manufacturing Park, Brunel Way, Rotherham, S60 5WG

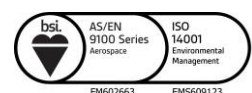
“UK and EU Cookie Law”

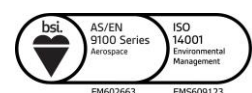
